



# Commitment to Community Award

In Honor of Mary B. Kraft

## History of the Award

Mary B. Kraft was the first employee, and a member of Home Nursing Agency's incorporating and charter Board of Directors. She recognized the importance of giving back to the community – whether the community of care that the Agency represented or the community in which she lives. This award, established in 1983, is presented to the employee most exemplifying the ideals and values of Home Nursing Agency and for distinguished service throughout the Agency and in his or her community, respectively.

## Who is eligible?

**Any full-time, part-time, or PRN employee of Home Nursing Agency is eligible.**

**Nominees should:**

- Show a strong commitment to the ideals of the Agency through a caring and respectful attitude while performing his or her responsibilities.
- Reflect the ideals of the Agency both as an employee and as a citizen of his or her community, as reflected in membership and active participation in community organizations.
- Understand and support the role of the Agency in the community.
- Perform quality work that has earned respect from his or her supervisors and co-workers.
- Fulfill required duties with exceptional ability and willingly respond to requests above and beyond assigned responsibilities.

## How is the recipient honored?

**Recipients will:**

- Receive \$250 cash.
- Receive a commemorative award.
- Have their names inscribed on a plaque in the Agency boardroom.
- Have an article sent to their local papers acknowledging receipt of the award.
