In Memory of Dot (Dorothy) Tartaglio

## History of the Award

Dorothy 'Dot' Tartaglio consistently exhibited an energetic, enthusiastic approach to her responsibilities and a willingness to go beyond the call of duty. The Extra Effort Award, first presented in 1987, was renamed in her memory in 1993 after her death. Dot was a long-standing employee and a former vice-president of Home Nursing Agency.

### Who is eligible?

Any full-time, part-time, or PRN employee of Home Nursing Agency is eligible. Nominees should:

- Reflect a strong commitment to the ideals of the Agency at work and in the community.
- Exhibit consistent energy, enthusiasm and willingly put forth the effort to make a difference for co-workers and the people entrusted within the Agency's care.
