In Memory of Glenda McGuire

History of the Award

Glenda McGuire helped create the spirit of Home Nursing Agency's hands-on care. She was one of our first home health aides – a position that is at the very heart of compassionate care. Today's home health aides and program assistants carry on her dedication to improving lives; often their care and assistance make the difference between keeping a loved one at home versus losing them prematurely to a long term care facility. This award was established in 1986 in Glenda's memory.

Who is eligible?

Any full-time, part-time, or PRN homemaker/home health aide/personal care aide, or program assistant is eligible for nomination. Nominees should:

- Show a strong commitment to the ideals of the Agency through a caring and respectful attitude for the individuals he or she serves and their families.
- Reflect the ideals of the Agency both as an employee and as a citizen of his or her community.
- Embody a warm, pleasant personality and remain flexible about his or her work.
- Maintain an ongoing interest with his or her responsibilities as demonstrated by regular attendance at staff meetings and education in-services.

How is the recipient honored?

Recipients will:

- Receive \$250 cash.
- Receive a commemorative award.
- Have their names inscribed on a plaque in the Agency boardroom.
- Have an article sent to their local papers acknowledging receipt of the award.
